WHEREAS, New Millennium Building Company, a Minnesota nonprofit corporation (the "Company"), has determined that Yee Yang and Nou Vang have attempted, without consent of the Company, to amend the articles of incorporation of the Company and to obtain possession of money that belongs to the Company; and

WHEREAS, the Company has determined to join as a plaintiff in litigation, along with New Millennium Academy (the "Charter School"), against Yee Yang and Nou Vang to stop these efforts.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE COMPANY, AS FOLLOWS:

The Company agrees to join as a plaintiff in litigation with New Millennium Academy against Yee Yang and Nou Vang to prevent them from obtaining possession or control over money or property belonging to the Company, and to establish that their attempt to file amended articles of incorporation for the Company was invalid, and to declare that the board of directors of the Company as appointed by the Charter School is the valid and acting board of directors of the Company.
